2024 CONSUMER CONFIDENCE REPORT

In an effort to keep you informed about the quality of water and services we provide to you each day, we're pleased to provide you with our Annual Water Quality Report. This report is a snapshot of the quality of water we provided you last year and includes details regarding the source of your water, what it contains and how it compares to EPA standards.

Our drinking water comes from Two Medicine Water. Their water comes from Two Medicine Lake. In order to maintain its purity, Two Medicine filters the water then treats it with a small amount of chlorine. We have 1,659 service connections. The EPA has conducted a sanitary survey inspection of Two Medicine Water. They determined one of the Browning tanks needed repairs. We completed those repairs in 2022.

Violations: We failed to provide you, our drinking water customers, with an annual report that adequately informed you about the quality of our drinking water and the risks from exposure to contaminants detected in our drinking water. The violation ended on 09/30/2024.

We are pleased to report that our drinking water is safe and meets all federal requirements. DID YOU KNOW? The sources of drinking water (both tap and bottled water) include rivers, lakes, streams, ponds, reservoirs, and wells. As water travels over the surface of land or through the ground, it dissolves naturally occurring minerals and in some cases radioactive elements. Water can also pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in water include:

- 1) Microbial contaminants such as viruses and bacteria which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- 2) Inorganic contaminants, such as salts and metals which can be naturally occurring or result from urban storm water runoff, industrial or domestic waste water discharges, oil and gas production, mining and farming.
- 3) Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.
- 4) Volatile organic chemicals, which are byproducts of industrial processes, petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.
- 5) Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, the EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for

public health. We take all of our water samples to Montana Environmental Laboratory in Kalispell (406-755-2131). They are a private laboratory that is certified by the State of Montana and the EPA to analyze drinking water.

Two Medicine Water performed the following tests to identify possible contaminants in our source water during the period of January 1 to December 31, 2022:

- One nitrate plus nitrite test – result was within EPA standards.
- One set of tests to determine the possible presence of 14 inorganic contaminants – results were within EPA standards.
- Tests to determine the possible presence of 61 organic contaminants – results were within EPA standards.

We performed the following tests to identify possible contaminants in our distribution system during the period of January 1 to December 31, 2022:

- 60 Coliform bacteria tests – all were coliform free.
- Eight sets of tests to determine the possible presence of 10 disinfection byproducts – results were within EPA standards.
- 20 tests on the water from our customers' homes to determine the possible presence of lead and copper leaching out of the faucets and fixtures – results were within EPA guidelines.

The following tables list the contaminants which have been detected in our water. Some of the data in these tables may be more than one year old, since certain chemical contaminants are monitored less than once per year.

DEFINITIONS:

MCL - Maximum Contaminant Level - The “Maximum Allowed” is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

MCLG - Maximum Contaminant Level Goal - The “Goal” is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

PPM - Parts per million or Milligrams per liter (mg/l) - one part per million corresponds to one minute in two years or a single penny in \$10,000.

PPB - Parts per billion or Micrograms per liter - one part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.

AL - Action Level - the concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

pCi/L - Pico Curies per Liter - a very small unit of measurement of radioactivity.

What does this table tell us?

As you can see, our system had no MCL violations. MCL’s are set at very stringent levels. To understand the possible health effects of exceeding the MCL, a person would have to drink two liters of water every day at the MCL for a lifetime to have a one in a million chance of having any adverse health effects. Although we have learned through our monitoring and testing that some constituents have been detected, your water IS SAFE at these levels.

All sources of drinking water are subject to potential contamination by constituents that are naturally occurring or man-made. Those constituents can be microbes, organic or inorganic chemicals, or radioactive materials. All drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. Lead in drinking water comes primarily from materials and components of the service lines and home plumbing systems. It is possible that lead levels at your home may be higher than other homes in the community as a result of materials used in your home’s plumbing. Our water system is responsible for providing high quality drinking water, but we cannot control the variety of materials used in private home plumbing systems. If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. If you are concerned about elevated lead levels in your home’s water, you may wish to have your water tested by a certified laboratory like the one we send our samples to (Montana Environmental Laboratory, 406-755-2131). When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap until the water temperature has stabilized (usually for 30 seconds to 2 minutes) before you use the water for drinking or cooking. Some people may be more vulnerable to contaminants in drinking water than the general population.
